Senior Reminders

- Once completed: see your guidance counselor for an application fee waiver and remember to sign-up for your official transcript to be sent by Mrs. Duncan in the guidance office.
- Financial Aid Forms: FAFSA priority deadline is November 1st. Failure to complete the FAFSA will result in limited to no financial aid to universities. This is also needed to receive many scholarships. complete the FAFSA as soon as possible. If you need assistance, please contact our MVCAP Representatives.
- If testing points have not been reached then grades, attendance, work hours, or the Capstone Project are the key to graduation. Please contact your child's counselor if you are uncertain of your child's status.
- YSU will be at WGH to complete applications on Nov. 9th & EGCC will be at WGH on Nov. 29th to complete applications. See your counselor to sign-up.
