Scheduling for the 2019-20 School Year

Tutoring is available daily, students are encouraged to attend. They must check-in to the WGH library by 2:45. Students should bring their class materials.

Subject specific tutors will be available on the following days:

- English tutoring: Monday & Tuesday
- Algebra I, Geometry, & Science tutoring: Monday-Thursday
- Algebra II tutoring: Thursday
- Student are also welcome to use the library & computers until 3:30 each day if they would like to stay to complete homework & study

Testing in the Spring of 2019

Testing is a requirement of the Ohio Department of Education. Your child will receive a detailed schedule of their testing dates through the months of March, April, & May.

- Students who have been enrolled in high school for three years will be required to take the ACT which is paid for by the state. On March 12, it is imperative that these students are in school on-time. There are very limited opportunities to make-up this test.
- EOC/AIR Testing: Students taking English I & II, Algebra I, Geometry, Biology, U.S. History, U.S. Government and any student who has not earned 18 points or lacks a proficient score in any previously attempted test. March 25-May 8.
- Results for students who attempted a test in December will be received the last week of February.
- Students enrolled in AP courses will test May 6-15.
